At-large Councilors may also be helpful. If the matter of interest has been scheduled for a Tuesday hearing before the Board of Appeal, it is important to get your comments to the board by the previous Friday. We are usually told that the best contact is a personal letter mailed to the party. If time is short, a fax is the next best thing, with e-mail as a back-up. If it is at all possible, you should **ATTEND THE HEARING** on your matter.
